Terms and Conditions

All transactions under this Sales Agreement are subject to the following Terms and Conditions:

1. In these Terms and Conditions, "Seller" includes Black Dog Veterinary Co., each of its divisions and subsidiaries, and their respective successors or assigns, any of which may enforce these Terms and Conditions against the Buyer listed above and any guarantor of Buyer's account.
2. Buyer agrees to pay each invoice in full according to its terms. Account statements will be furnished monthly (unless there are no sums due). Payments are due and payable at the address stated on the invoice or statement. For any amount that is not paid when due, Seller may charge a monthly finance charge of $\frac{3}{4}$ % per month, or eighteen percent (9%) per annum. Seller may allocate Buyer's payments first to any unpaid finance charges and then to the unpaid balance due on Buyer's account. In addition, Buyer shall be liable and shall pay on Seller's demand all costs incurred by Seller in connection with collecting Buyer's accounts, regardless of whether suit is brought, including collection agency fees, court costs, witness fees, and all reasonable fees and disbursements of Seller's or any collection agency's legal counsel.

3. If any payment due Seller is not made when due, Buyer's opportunity to purchase on credit may be restricted or terminated in Seller's sole discretion. Seller reserves the right to change any credit terms, or require cash on delivery, if any payment is not made when due.
 4. Seller shall have a purchase-money security interest in all goods purchased by Buyer until the purchase price and all other charges have been paid in full. Buyer authorizes Seller to prepare and file financing statements or other documents in order to perfect this purchase-money security interest.
 5. No goods may be returned without Seller's prior approval. Restocking charges and other conditions may apply, according to Seller's return policies which may be revised by Seller from time to time.
 6. By the signature below on behalf of Buyer, the undersigned: (a) represents and warrants that all information provided by or on behalf Buyer is true and correct in all respects; (b) represents and warrants that the undersigned is duly authorized to execute this agreement on behalf of Buyer; and (c) agrees to personally guarantee Buyer's full and timely performance of all of Buyer's obligations to Seller, including payment when due of all amounts due on any invoices or statements issued by Seller, all costs incurred by Seller in collecting any amount due, and all costs incurred by Seller in enforcing any provision of this Agreement.
 7. By providing an email address or fax number, Buyer consents to receive invoices, statements and other information from Seller via email or fax.
 8. This Agreement shall be governed and interpreted by Pennsylvania law, without regard to its conflicts of law's provisions.
 9. All terms of credit offered by Seller are subject to change at any time. Changes shall take effect upon or as provided in written notice from Seller.
